Minutes from the December meeting were approved.

Treasurer's Report:

EPC Report: Ruth reported that the EPC *will* change the historic meeting date to the 2nd Thursday of each month to meet the needs of Mr. Peterson to be Chair. Also discussed was the constitutional right to cross examine. This has gone to committee.

Reforestation of North/South streets. Katy reviewed the proposal to the NM State Legislature for funding from either the Legislature or, more likely from the stimulus. Our request was addressed to Senator Jerry Ortiz y Pino.

Zoning:

- 1900 Silver – Variance hearing is set for 1/19/10; Gordon has written in opposition to Tom Rojas, Assistant Zoning Hearing Officer.
- 1607 Coal (3 townhomes) – The City of ABQ said, “no” to the 3 units. Seavy filed an appeal and the Appeals Officer upheld the neighborhood’s position. However the City Council subsequently approved his appeal to build.

Safe Routes to Schools: Gordon received an e-mail from this movement encouraging children to follow ordained paths to school for safety.

Metro Court Judge presentation: Judge Judith Nakamura has offered to speak to neighborhood groups. The SHNA Board voted unanimously to ask her to present to this and other neighborhoods in the University Federation. Gordon will talk to Mardon Gardella and report back at the next Board Meeting.

Neighborhood Board Training: The Board asked Gordon to talk to Don Hancock about doing this training as soon as possible. Gordon will do so and report back at the next meeting.
